I understand that MELISSA F HILL CPA PC will follow whatever position I request, so long as it is consistent with the codes and regulations and interpretations that have been promulgated. If the IRS or state tax authorities should later contest the position I request, there may be an assessment of additional tax plus interest and penalties. I further understand that MELISSA F HILL CPA PC will have no liability for such additional taxes, penalties or interest.
- 3. I understand that taxing authorities may examine the return(s), therefore documentation should be retained to support the information I provide to MELISSA F HILL CPA PC especially business travel and entertainment deductions, business use percentage of autos and other assets, barter activities, and charitable contributions.
- 4. I understand that MELISSA F HILL CPA PC will not verify any information I provide, however MELISSA F HILL CPA PC may require clarification or additional information, and that MELISSA F HILL CPA PC will not be responsible for disallowed deductions or the inclusion of additional unreported income or any resulting taxes, penalties, or interest.
